

SUGARS BRIDGE FARM LLC “TOUR AND EVENT”

RELEASE AND HOLD HARMLESS AGREEMENT

Tour and Event at Sugars Bridge Farm, LLC: _____ (collectively, the “Event”)

I wish to participate and/or give permission for my child to participate in the Event and agree as follows:

1. There are Conditions, Hazards and Risks of Participating in the Event.

I fully understand that:

- the Event is taking place on farm property that includes farm animals (such as alpacas, llamas, dogs, cats, chickens, ducks, and other animals), uneven ground and other inherent hazards of being on a farm
- my/my child’s participation in the Event’s activities will involve conditions, hazards, and risks which could result in loss or damage to personal property, illness, or injury (including death), including but not limited to, the actions or reactions of farm animals or humans, uneven ground conditions, inclement weather, venue facilities, accidents, or illnesses
- Sugars Bridge Farm, LLC is not an insurer and cannot and does not assume responsibility for any of these conditions, hazards, or risks or for any related personal injuries or property damage.

2. I Assume All Risks and Responsibilities.

I, on behalf of myself, my child, my family, heirs and personal representatives, assume all the risks and responsibilities surrounding my/my child’s participation in the Event. I am solely responsible for my own/my child’s safety during participation in the Event.

3. I Waive and Release the Releasees from Liability and Covenant not to Sue

I release, waive, forever discharge and covenant not to sue Sugars Bridge Farm, LLC, its members, officers, agents, employees, and volunteers (collectively, the “**Releasees**”) from and against all liability for any harm, injury, damage, claims, demands, actions, causes for action, costs and expenses of any nature whatsoever, which I/my child may have or which may hereafter accrue arising out of or related to any loss, damage, or injury. This includes but is not limited to suffering and death that may be sustained by me/my child or by any property belonging to me in connection with participating in the Event even if such loss, damage, injury was caused by the negligence or carelessness of any of the Releasees regarding the Event.

It is my express intent that this release and hold harmless agreement shall be deemed a release, waiver, discharge, and covenant not to sue the Releasees. I further agree to save and hold harmless, indemnify, and defend the Releasees from any claim by me or my family arising out of my/my child’s participation in the Event.

4. Photographs May be Taken.

I understand that while participating in the Event, I/my child may be photographed. I agree to allow their photo, video, or film likeness to be used for any legitimate purpose by Sugars Bridge Farm, LLC.
